Dear Kalli,

I was 22 years old when I joined the India Today Group. I've now been here for 22 years — that's half my life. Had someone told me, fresh from completing the Chevening Fellowship in the UK and returning to India, that I would spend more than two decades in this organisation, I wouldn't have believed it.

It's a testament to the vibrancy of this great institution that a curious young journalist like me found professional fulfilment and growth year after year. Never did I feel stagnant, constrained, or compelled to compromise. Your steadfast courage — your refusal to bow when bending might have been easier — has earned my deepest respect. Your commitment to principled journalism has been a priceless gift, not just to me, but to everyone who calls the India Today Group home.

Over these two decades, I have given this network everything I had — my conviction, my craft, my voice. It shaped me. It stretched me. It gave me a front-row seat to the making of history. Leading the India Today and Aaj Tak newsrooms has been the greatest honour of my life.

Your heartfelt words about the value I bring to the India Today Group — your appreciation of my work ethic and talent — mean more to me than you will ever know. I've always seen myself as a trustee of the institution: fiercely loyal to its principles, invested in its legacy, and proud to carry its flag.

Throughout my time here, Mr. Purie and you encouraged us to push the boundaries of what was possible, while remaining fair and balanced in our coverage. I remember AP once telling me, "*When you carry a big stick, you can talk softly and the world will listen. You don't need to shout to be heard.*"

AP has been much more than a boss — he's been a mentor, a guide, a lodestar. A second father. The things he's said over the years are etched into my journalistic DNA. He once jokingly remarked, "*Don't think you are the cat's whiskers. If you've become good over the years, it's because of all the pastings you've got from me.*" He may have said it in jest, but I believe it to be true.

As we navigate this transition, I hope you'll look back on our time together with pride in what we've built. This decision has not been easy, but I wish that even when I'm no longer on the newsroom floor, you will hold warmth in your heart and goodwill in your mind.

Thank you — for your faith, your friendship, and your formidable leadership. Very few people lead with equal parts warmth and wisdom. Fewer still make others feel truly seen and valued. You've done both. And for that, I will always be indebted.


